



COVID-19 DECISION TREE – STUDENTS

- Possible COVID-19 Symptoms**
- Fever (Over 100.3°F)
 - Loss of smell or taste
 - Cough
 - Muscle aches
 - Sore throat
 - Shortness of breath
 - Chills
 - New or unusual headache
 - Nausea, vomiting, diarrhea or loss of appetite

YES SYMPTOMS



- STUDENT WILL**
1. Notify administrator and **stay home** or if at school, student will be isolated and needs to be picked up within 60 minutes
 2. Contact physician and follow medical care and advice
 3. Coordinate with administrator to obtain COVID 19 Test per DOPB Protocol
- ADMINISTRATOR WILL**
1. Coordinate with student to obtain COVID-19 Test per DOPB Protocol
 2. Work with student to determine Contact Tracing

NO SYMPTOMS



Is Student aware of someone who has been diagnosed with or tested positive for Covid-19 with whom they may have been in contact

- Yes, there was direct physical or close contact (less than 6 feet) for 10 minutes or more where neither parties were using face masks or coverings.**
- STUDENT/PARENT WILL**
1. Notify administrator and **obtain a Covid-19 Test** per DOPB Protocol
 2. **Stay home** and monitor by checking for fever and symptoms.
 3. Follow directives for “If Student Tests positive” or “If Student Tests Negative”
- ADMINISTRATOR WILL**
1. Coordinate with student to obtain COVID-19 Test per DOPB Protocol
 2. Work with student to determine Contact Tracing

- Yes, there was non-close contact (greater than 6 feet) and/or the contact lasted less than 10 minutes.**
- STUDENT/PARENT WILL**
1. Self-monitor by checking for fever and symptoms.
 2. Continue practicing social distancing and good hygiene.
 3. Follow directives for “YES SYMPTOMS” if symptoms appear
- ADMINISTRATOR**
1. No specific action is needed.

- No, the student is unaware of any contact with someone who is known to be infected or diagnosed with COVID-19**
- STUDENT/PARENT WILL**
1. Continue practicing social distancing and good hygiene.
- ADMINISTRATOR WILL**
1. No specific action is needed.

If Student Tests **Positive**

- STUDENT/PARENT WILL**
1. Notify administrator of the result
 2. Continue medical care as instructed
 3. Return to school **only** after: **72 hours** have passed since **complete recovery** (No fever and improvement of respiratory symptoms) **AND** 12 days have passed since symptoms first appeared
- OR**
- 2 negative COVID tests** done at least 24 hours apart (provide copy of results to administrator)

If Student Tests **Negative**

- STUDENT/PARENT WILL**
1. Notify administrator of result (provide printed copy of results)
 2. Continue medical care as instructed
 3. Return to school **after 48** hours have passed since recovery (No fever and general improvement of symptoms) **AND** negative test results.
